Description of Service

TCG's Compliance Essentials Solution is designed for new entrants and small service providers in Cloud Communications (VOIP) and Wireless (MVNO) markets. The Solution combines powerful tax engines' data with expert knowledge to ensure regulatory compliance and cost management. It uses technology and professional insight to maintain compliance while managing costs, without compromising quality.

Service Components and Pricing

The Compliance Essentials Solution includes the services listed below. It is offered as a bundled package for a monthly subscription fee of \$750, which includes a base license fee for a third-party tax engine software.

- AccuLicense Service
- AccuAgent Service
- AccuReg Service – FCC Only
- Compliance Risk Management (CRM) Service
- License to Tax Engine Software Database

Qualification Requirements

To qualify for the Compliance Essentials Solution:

- Your monthly "telecom" revenue must be under \$25,000 USD.
- Your services must include VoIP (Interconnected and One-Way) or Wireless.

Basic tax mapping services availability depends on qualification through the Discovery Process.

Pricing and Payment

Before service commencement, sign an Order Form and Agreement with TCG to initiate pricing and fees:

- \$750 monthly subscription fee (covers specified services).

- \$2,500 one-time or \$250 per month fee (for Basic tax mapping).
- Billing of monthly subscription fee starts after the 60-day onboarding period.

Escrow and Billing

TCG may act as a fund transfer agent. You must establish and fund an Escrow Account to cover fees and taxes. Failure to fund Escrow may result in suspension of services.

Termination

Two phases of the Agreement are outlined:

- Pre-Qualification: 60-90 days (termination fee: \$250 + admin fees)
- Post-Qualification: 12 months (60-day onboarding period)

Suspension and Termination

TCG may suspend services for non-payment or terminate in case of default. Early termination fees may apply, and prepaid payments may be forfeited.

Billing and Payment

- Charges are collected through the selected payment method. Work starts after payment receipt.
- One-time and recurring fees are billed in advance. Billing disputes must be raised within seven days.

Effect of Expiration, Suspension, or Termination

Upon expiration or termination, rights granted cease. TCG may terminate access to licensed software. Customer remains liable for unpaid charges, costs, and fees.
